
# Counselling Process Quick Guide

# Who is Eligible to Participate in COMEDK Online Counselling?

- Candidates with COMEDK Engineering Entrance Exam Rank Card 2022
- Have passed 12th/2<sup>nd</sup> PUC/ equivalent examination with English as one of the languages, Physics and Mathematics as compulsory subjects along with Chemistry/Biotechnology/Biology/Electronics/Computer Science.
- The General Merit candidates should have passed 12<sup>th</sup>/2<sup>nd</sup> PUC/ equivalent examination with a minimum aggregate of 45% marks (40% in respect of SC, ST and OBC candidates of Karnataka State) in Physics, Chemistry and Mathematics and should have passed these subjects individually
- # Supplementary candidates of PU Board/10+2 of current year (passed supplementary exam in the year 2022) satisfying all the eligible criteria should register during the initial Counselling registration period and they have to upload all the required mandatory documents within the prescribed time limit. There will be no separate registration period for supplementary candidates.
- # For the candidates who are yet to appear for the supplementary exam in the current year i.e. 2022, they can upload all other required mandatory documents except the 10+2/2<sup>nd</sup> PUC Marks sheet. Such candidates will be given an opportunity to upload their 12<sup>th</sup> STD/2<sup>nd</sup> PUC marks sheet to prove their eligibility before start of Round 3.
- Eligible candidates who have registered themselves for online counselling with a non-refundable registration fee of Rs. 2,000/-
- Candidates who are ready to pay entire college fee at COMEDK level after allotment of seats.
- Candidates having all mandatory documents to prove eligibility, scanned and ready to upload since their candidature is subject to successful verification of the same and approval.

# How to register for Online Counselling?

- Login to COMEDK Application Form on <a href="www.comedk.org">www.comedk.org</a>, using Laptop/desktop.
- Click on "Counselling Registration" Tab
- Make Payment of Rs 2000/- as non-refundable counselling registration fee using credit card/debit card/net banking
- Click on "Document Upload" tab
- Upload all mandatory documents for verification.
   (Ensure uploading legible scanned images of documents. Do not take photo of the documents in mobile for uploading. The image should be only JPG, JPEG or PDF format)

# Only candidate's whose Document Verification Status shows 'Document Approved' will be eligible for further process

How to check whether document is verified?

- The document verification status will be updated in your application login in 'Document Upload' tab
- You are requested to login to your application frequently to check for document verification status which could be any one of the statuses mentioned below:

- Candidates whose document verification shows 'Document Approved' will only be considered for next step of 'Choice Filling"
- In case incorrect/illegible documents are uploaded; your counselling registration and verification status may show as 'Document Rejected'
- Candidates whose document verification status is incomplete/rejected will not be able to participate in further process
- In case of incorrect declaration in application form or documents, your candidature may be rejected at any stage of counselling/admission process

- 2) Date of Birth Proof of Candidate: PAN/Passport/Voter Id/ Driving License/ Any other Government Id Proof/ 10<sup>th</sup> Marks Card//Birth Certificate
- 3) PUC/ 12th Std or equivalent Marks Card: (CBSE Candidates should upload marks card which shows Roll Number and School Number and clear QR code/ I.S.C board candidates should upload marks card which shows Unique ID Number and Index Number and clear QR code.)
- 4) Admit Card (IF APPLICABLE/CBSE CANDIDATE)
- 5) Improvement or Supplementary Marksheet or any other document (If applicable)
- 6) **SC/ST/OBC Certificate**: Applicable only if you have scored between 40 to 45% in 12th grade/2<sup>nd</sup> PUC/Equivalent and are a Domicile of Karnataka
- 7) **Domicile Certificate**: Candidates claiming SC/ST/OBC category should upload Karnataka Domicile Certificate

### DOCUMENTS TO UPLOAD FOR HYDERABAD KARNATAKA REGION (HKR) SEAT- Engineering

- 1) Candidate Original ID proof: PAN/Passport/Voter Id/ Driving License/ Any other Government Id Proof (as declared in application form/used during exam)
- 2) Date of Birth Proof of Candidate: PAN/Passport/Voter Id/ Driving License/ Any other Government Id Proof/ 10<sup>th</sup> Marks Card//Birth Certificate
- 3) **PUC/ 12th Std or equivalent Marks Card:** (CBSE Candidates should upload marks card which shows Roll Number and School Number and clear QR code/ I.S.C board candidates should upload marks card which shows Unique ID Number and Index Number and clear QR code.)
- 4) Admit Card (If applicable/ CBSE Candidate)
- 5) Improvement or Supplementary Marksheet or any other document (If applicable)
- 6) **HKR Certificate**: Candidates claiming HKR seat should upload HKR certificate. Should be in the name of the candidate issued by Asst. Commissioner in charge of Revenue sub division
- 7) **SC/ST/OBC Certificate**: Applicable only if you have scored between 40 to 45% in 12th grade/2<sup>nd</sup> PUC and are Karnataka Domicile
- 8) **Karnataka Domicile Certificate**: Issued by Revenue authority not below the rank of Tahsildar, in the name of the candidate

NOTE: Candidates claiming SC/ST/OBC category need to upload SC/ST/OBC certificate and Karnataka Domicile certificate

Candidate claiming HKR seat need to upload HKR certificate and Karnataka Domicile Certificate

SC/ST/OBC is only to get lower eligibility of 40 to 45% and there is no reservation in COMEDK for these categories

# Counselling Rounds — Stages

- There will be 3 rounds of counselling
- Eligibility to participate in Round 2 and 3 will depend on choice exercised or decision made on allotment during Round 1 and 2 respectively
- \*Candidates passed out in Supplementary exam conducted by PUC Board/10+2 during current year (passed in year 2022) will be given a chance to participate only in Round3 of counselling.
   The options available to them if allotted a seat in Round3 will be 'Accept & Freeze or 'Reject & Withdraw'.

# Round1

GENERAL MERIT/ HKR-SEATS

Eligible only if student has a COMEDK Rank, has paid Counselling Registration fee and document verification is successful/approved.
Supplementary candidates are not eligible for Round1

CHOICE FILLING form will be available only for applicants whose documents verification status is approved.

Fill all college and Course Preference in CHOICE FILLING Form

Check saved preferences by checking Print preview option on screen. Save document for future reference. Choice filling is mandatory to continue in the counselling process

Check Mock Allotment Result

Make changes in CHOICE FILLING Form, if required

Check Round 1 Allotment Result

Make decision on allotment: Accept & Freeze/Accept & Upgrade/Reject and Upgrade/Reject & Withdraw

Candidates who have taken a decision of Accept & Freeze or Accept & Upgrade in Round1 will have an option to surrender/cancel seat during Surrender period of Round1 or Surrender period of Round2

# Round2 Phase1

HKR-SFATS

Eligible if you are a HKR candidate and if you were alloted a seat in Round1 and selected Accept & Upgrade or Reject & Upgrade OR Participated in Round1 but was not alloted any seat

# **SEAT MATRIX & FEES**

Please note: The fee amount mentioned below is of the year 2021-22 and the fee details for current year (2022-23) will be updated shortly.

- Seat Matrix indicates the number of seats available for seat allocation of a course and college combination
- The fee is called Total Fees and is dependent on the college and course and will be available in the Seat Matrix information
- The Total Fee of each college along with the number of seats will be published on COMEDK website under Counselling Details – Engineering Seat Matrix & Fee Structure
- The Total Fee of each college includes Tuition Fee + Other Fees per year. Apart from this, the following fee will be collected at college level:
  - Colleges providing special skill lab facilities may collect Rs. 10,000/-, Rs. 15,000/and maximum of Rs. 20,000/- per student per annum depending on the facilities provided by the institutions.
  - Applicable University fees
- In case of 'Accept and Upgrade'/'Reject and Upgrade' candidates, the Total fee paid at time of decision making, will be adjusted to the fee applicable for the college and course allotted during subsequent round/s as mentioned below:
  - Should there be an increase in Total Fee payable at time of Decision making in subsequent round: the extra fees will have to be paid by the candidate at the time of his/her decision making
  - Should there be a decrease in Total Fee payable at time of Decision making in subsequent round: the excess fees will be refunded by COMEDK after completion of the counselling process

CAUTION: In case, the candidate does not take any action on the seat allotted for the first time, it will be considered as Reject & Withdraw and he/she will not be eligible for further rounds.

If a candidate is not allotted a seat in Round1 because of less preferences. Such a candidate will not see any decision buttons and will move to the next round by default

There is a reason for providing four different choices/decisions to the candidate and it depicts specific outcome, when selected. Therefore, once the choice/decision is made, it will not be modified under any circumstances. The candidates are cautioned to make the choices/decisions carefully.

# SURRENDER POLICY/SEAT CANCELLATION

Any candidate, who has accepted a seat during Round1 or Round2, can surrender their seat within the time period mentioned in Counselling Schedule for Seat Surrender. Such candidate is not eligible to participate in any of the subsequent rounds.

There is no facility to surrender the seat after the seat is allotted in Round 3 and the candidate has to join the allotted college. Please check fee refund policy in the fee refund section of this document.

### WHEN CAN CANDIDATE SURRENDER SEAT

Accept & Freeze and Accept & Upgrade seats in Round1	As per schedule/ deadline for surrender before Round 3 allotment. Round1 candidates can surrender during surrender period of Round1 or during surrender period of Round2

# FEE REFUND POLICY FOR 'TOTAL FEE 'PAID AT COMEDK

In case a candidate wishes to cancel his/her seat, he or she has to surrender the seat during the surrender period only, which will enable him/her for refund of entire Total fee paid at COMEDK level.

There is no surrender period after Round3. Any candidate allotted a seat in Round3 will have to join the college that is allotted.

If a candidate whose name is in the final list, fails to join/report and continue the study in the allotted college, he /she will forfeit the entire tuition fee including other fees paid at COMEDK level since the candidate has deprived an opportunity of getting allotted a seat to next best/merited candidate thereby blocking a seat and the candidate is also liable to pay a penalty of five times of the fee.

### **SUPPLEMENTARY CANDIDATES TO NOTE**

Many students taking Supplementary/ Compartment exam in 2022 have expressed their concern as their results will not be available before the start of Round2 Phase2 counselling and requested to allow them to participate in Round3 instead of Phase2 of Round2. Keeping in view the interest of supplementary students, it has been decided that all the supplementary candidates of current year (i.e. those who have passed the supplementary exam in 2022) will be allowed to participate in Round 3 counseling of COMEDK UGET 2022. The same has been brought out in the Counseling Process Document also.
