## Sub: UGET 2021 - Conduct of Exclusive Round of Counseling for Engineering & Architecture Courses

COMEDK has published the allotment result of its Round 3 counseling for Engineering and Architecture courses on 24.12.2021 which was in accordance with the schedule already published. It was informed in the Counseling Process Document dtd. 5.11.2021 that there will be an Exclusive Round of Counseling wherein the Supplementary candidates of the current year will be given an opportunity to participate in allotment process.

In view of the above, COMEDK is conducting the Exclusive Round of Counseling, the schedule and process of which is annexed to this notification. Supplementary candidates of current year whose document verification is approved only are eligible to participate in the Exclusive Round of counseling. These candidates have to provide their consent for participation in the Exclusive Round.

Please note that the allotment for this round will be purely based on general category seats only. Since this is the final round of counseling, all the candidates who want to participate in this round have to pay fee of Rs. 2,21,960/- in advance at the time of providing consent for participation.

Further, the Hon'ble Supreme Court in MA No. 1955/2021 in CA No. 9048/2012 has extended the last date for admission to Engineering courses till 31.12.2021. Keeping in view the paucity of time, the candidates who are allotted a seat in the Exclusive Round of Counseling are required to report to the allotted college before 4:00 PM of 31<sup>st</sup> Dec 2021 and complete all other formalities before 4:00 PM of 3<sup>rd</sup> Jan 2022. Therefore, the candidates who are participating in Exclusive Round are requested to make travel arrangements in advance so as to ensure reporting to the allotted college in time.

All other terms and conditions set out in the Counseling Process Document published on 05.11.2021 and subsequent notifications shall prevail to the extent not contrary to this notification.

## Steps for participation in Exclusive Round

- 1. Opening of consent form for eligible candidates.
- 2. Candidate consents to accept seat that is allocated in Exclusive Round. All candidates who provide consent have to make payment of Rs. 2,21,960/- in advance.

In case the Total Fee of the college and course allotted during exclusive Round is LOWER than the fee paid at time of providing consent: The excess fees will be refunded by COMEDK after completion of the counselling process.

In case the Total Fee of the college and course allotted during exclusive Round is HIGHER than the fee paid at time of providing consent: The excess fees will have to be paid by the candidate at the time of reporting to college.

- 3. Choice filling will be available only for candidates who provide consent and have completed payment as mentioned above.
- 4. Candidate will fill only the college/s and course/s that they are willing to join.
- 5. Allotment is shown to candidate in Decision making tab and the decision will automatically show as 'Accept and Freeze'.
- 6. Candidate clicks on 'Receipt and Allotment Letter' tab and prints allotment letter & Fee Receipt and reports to the college. There is no option to Reject the seat allotted.
